Mr. Carpenter's opinion is that they are only called in when the snow is bad and when service department is not plowing therefore they are deemed emergency workers who should not get OPERS. Mr. Molina's opinion is that they are on a schedule to work when service department is not working their regular shift which would avoid overtime so he feels they are employees and should get OPERS. Mr. Carpenter stated whatever Council's intent is, they just have to notify Ms. Wordell to include them on OPERS. Mr. DiCarlo would like legislation written up as well to clarify that they are going to be receiving OPERS.

New Business

Mr. Hoffmann made a motion to authorize the fiscal officer to advertise for the recreation center manager position and to accept applications for such. Mr. DiCarlo seconded. All in favor.
