A RESOLUTION TO HIRE INDEPENDENT CONTRACTORS AS FITNESS INSTRUCTORS FOR THE REMINDERVILLE ATHLETIC CLUB, AND DECLARING AN EMERGENCY.

SECTION 21: That Tina Sweatt is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Ballroom Dancing, effective January 1, 2017 through June 30, 2017, and to be paid \$10 per person, \$20 per couple, and

SECTION 22: That Michelle Titos is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Zumba, effective January 1, 2017 through June 30, 2017, and to be paid \$24/per class, and

SECTION 23: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the Village of Reminderville, to wit: to insure immediately placement, and if this Resolution receives the necessary number of votes, it shall take effect and be in force from and after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
