

RESOLUTION NO. 80-2017

A RESOLUTION TO HIRE INDEPENDENT CONTRACTORS AS FITNESS INSTRUCTORS FOR THE REMINDERVILLE ATHLETIC CLUB, AND DECLARING AN EMERGENCY.

WHEREAS, the Athletic Director has recommended hiring independent contractors as fitness instructors for the Reminderville Athletic Club, and

WHEREAS, Council finds good cause to accept the recommendation of the Athletic Director, now, therefore,

BE IT RESOLVED, by the Council of the Village of Reminderville, County of Summit, and State of Ohio:

SECTION 1: That Pamela Miller is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Senior Line Dancing, effective July 1, 2017 through December 31, 2017, and to be paid \$3.00 per participant, and

SECTION 2: That Artist at Heart is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Paint Parties, effective July 1, 2017 through December 31, 2017, and to be paid at the rate of \$25.00 per participant, and

SECTION 3: That Stephanie Bowlin is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Workshop for Early Communications, effective July 1, 2017 through December 31, 2017, and to be paid at the rate of \$41.00 per participant, and

SECTION 4: That Stephanie Bowlin is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Beginning Play Class, effective July 1, 2017 through December 31, 2017, and to be paid at the rate of \$76.75 per participant, and

SECTION 5: That Joe Daugirdas is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Travel Class, effective July 1, 2017 through December 31, 2017, and to be paid at the rate of \$100.00 per class with a minimum of 15 participants, and

SECTION 6: That Joe Daugirdas is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Savvy Shopper, effective July 1, 2017 through December 31, 2017, and to be paid at the rate of \$100.00 per class with a minimum of 15 participants, and

SECTION 7: That Empowered & Poised is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Empowered & Poised, effective July 1, 2017 through December 31, 2017, and to be paid at the rate of \$120.00 per participant, and

SECTION 8: That Future Scientists is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Future Scientists, effective July 1, 2017 through December 31, 2017, and to be paid at the rate of \$57.50 per participant, and

SECTION 9: That Kimberlee Franz is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Etiquette Classes, effective July 1, 2017 through December 31, 2017, and to be paid at the rate of \$20.00 per class, and

SECTION 10: That Courtney Ross is hereby hired as an independent contractor for the Reminderville Athletic Club to be the head personal trainer, effective July 1, 2017 through December 31, 2017, and to be paid at the rate of \$37.50 per personal training package of 1 session, \$270 per personal training package of 8 sessions, \$480 per personal training package of 16 sessions, and

SECTION 11: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the Village of Reminderville, to wit: to insure immediately placement, and if this Resolution receives the necessary number of votes, it shall take effect and be in force from and after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
