

Village of Reminderville Committee of the Whole April 12, 2016

Call to Order

Meeting was called to order by Mr. Molina at 6:58pm

Approval of Minutes

Mr. DiCarlo moved to approve minutes from March 22, 2016. Mr. Kondik seconded. All in favor except Mr. Hoffmann who abstained.

Amendments to the Agenda

Mr. DiCarlo moved to add Resolution 33-2016 to the agenda. Mr. Kondik seconded. All in favor.

Mayor's Report

Mayor Alonso reported the demolition of the Village-owned house on Georgia Street will take place in early May. Twinsburg is going to detour traffic going up Glenwood to Rt. 91. You will be able to get to Heinen's but not to Rt. 91. The detour will take you to Post Road to get to Rt. 91. He then reported if residents have flags they would like to discard due to condition, they can take them to VFW Post 4929 in Twinsburg. They will be doing a flag burning ceremony on April 30 at Chamberlin Park at noon.

Law Director

Mr. Carpenter reported he spoke with Chief Buck regarding Ordinance 08-2016 for the Parking Violations Bureau and he would like it to go by emergency so he can turn it in to the Court for approval. Mayor Alonso asked if it will bring in enough money to cover the costs. Mr. Carpenter feels it should and hopefully they can use Police Department Administrative Assistant Mark Wilson to collect money. There will also need to be someone hired to hear appeals; that person has to be a former police officer or a lawyer. Mr. Wiggins asked what the

impetus was to form the bureau. Mr. DiCarlo replied there are cars parked on the street overnight and during the winter; blocked driveways; parking on both sides of the street causing traffic problems. Right now the police officers go to the door and tell the resident to move their car.

Engineering

Mr. Bowlin reported they are waiting on an update on the NTO Bridge. He asked Mr. Carpenter to draft a letter to ECS requesting a meeting to push it forward. There is a clean-up project slated for the salt barn and they are working out a deal with Savarino's to take what they can to chip and they would offset some of the purchases that are made through the Service Department. TriMor would work on the remainder of the clean-up not to exceed \$25,000. He also reported the California Street project will have a summertime start. He will be working on closing out the Cleveland Water portion of the Regatta punch list. Liberty Ledges Phase 4 is ready to go once legislation is passed. Mr. Silversten asked about the second entrance issue in Liberty Ledges. Mayor Alonso said the developer told him he had a good meeting with the residents and they are happy with the way it was and the things he promised. Mr. Bowlin reported the senior apartments are on hold due to replacement of the HVAC sub-contractor. Glenwood Greens were approved for their variance. Mr. Molina reported the service department's list included looking over the senior driveways for plow damage, getting pricing for roof gutter cables at Heritage Hall and service garage, cleaned Glenwood Blvd, painted the inside of the service garage, and are getting ready for springtime work.

Recreation Center

Mr. Molina reported the pool is in and they are pouring the concrete and picking out tiles. They are also looking at floor samples for the different rooms in the building. Mr. DiCarlo stated he has not noticed a difference on the outside of the building and asked if there was any work being done. Mayor Alonso suggested he look inside the building to see all of the work that has been done and stated they cannot close the gap in the outside walls of the building until the pool area is done because they need an entrance space to get the large equipment inside.

Fiscal Officer

Ms. Wordell reported the 2014 and 2015 audit went smoothly. She will receive the full report in June. She thanked Ms. Task for keeping thorough records and organized legislation. She also stated it was Ms. Task's birthday.

Assistant Chief Johns reported he will be conducting a fire extinguisher class for Village employees for insurance purposes. The Civil Service test for lieutenant will be on April 21. He also stated there may be a helicopter fly-in for training purposes for landing in the Village.

Mr. DiCarlo asked for explanation. Mayor Alonso stated the EPA wanted them to move the salt barn. They provided a plan to mediate the issues on site and the EPA agreed to it. The concrete will be crushed up and used in the construction for the police department addition entranceway as well as a berm around the salt barn. The EPA is fining the Village \$10,000; it would have been \$275,000 to move it. Mr. DiCarlo would like the agreement and legislation to be revised to reflect the clean-up of the materials being used by the police department be charged separately to them.

Old Business

Mr. DiCarlo asked if the permissive tax could be used for the costs with the salt barn. Mayor Alonso replied it could not.

New Business

Mr. Molina reported on April 22, Earth Day, Summit Metro is offering free bus rides. He then requested legislation be written up for 911 Cellular with the plan to have the \$13,000 cost split between the fire department and the police department. Mr. Silversten stated his only concern is being able to properly educate the residents on use of the 911 Cellular system. Mayor Alonso stated they have people who can help explain the system.
