# **Engineering**

Mr. Bowlin reported the restoration work on the Nautilus Trail culvert is complete. Tri Mor will be out early October to finish the punch list for Regatta Trail. Two

residents on California Street will be contacted about a potential easement for the storm sewer outlet. Mr. Bowlin also reported Cleveland Water indicated none of the streets submitted qualified for funding. Streets that were submitted were Anchorage, Ensign, Skippers, Smugglers, and both Surfsides. Glenwood Greens has only one lot left. Liberty Ledges Phase 6 site work is in progress. Herrington Phase 9 is ready to pave.

## **Service Department**

Questions have been raised about the amount of donations given to Twinsburg and why the Village does not ask for donations in return. Mr. Molina presented a report made by Mr. Scaffide of the services and items Twinsburg, Township, and Glenwillow have assisted Reminderville with. These include use of their electricians at no cost, street sweeping two times a year at reduced cost, tables and chairs with no rental fees, use of their bucket truck at no cost, emergency sewer cleaning at reduced rate, pavement repair at a reduced rate, free CDL training for the service crew, and shared equipment.

## Reminderville Athletic Club

Mr. Apinis reported the RAC 24/7 fitness area is now open and being used. Final inspections for the pool and Splashpad are this week. There has been a number of staff that left due to family reasons or schedule conflicts with their other jobs and that is why there is legislation to hire more employees. The Open House is on October 1 with giveaways. They have added a special preview night for Reminderville residents only with giveaways on September 30. Silver Sneakers has been approved and they are finalizing the paperwork and training. They will be in contact with those who were put on the wait list. Classes will be starting soon, staff has been trained in CPR, and the final coat is going on the gym floor. They are at just under 400 memberships right now with over \$62,000 in revenue including latchkey. 244 memberships are from Reminderville, 90 from Aurora, 41 from Twinsburg, 4 from Streetsboro, 1 from Macedonia, 1 from Kent, 2 from Solon, 1 from Hiram, and 1 from Salem.

Chief Buck reported the Halloween party is being moved to the RAC due to the construction at the police station. The construction is under way and they will begin building the walls. He stated the first pay app is in and the Village will pay the \$150,000 they committed on that.
