**Linda Radecky 2992 Pirates Cove**

Ms. Radecky stated there are at least five people who park their cars on Pirates Trail day and night, all year long. They have been asked to move and they won't. She gave an example of an officer asking a resident to move their car onto the grass just to get it out of the way because they wouldn't put it in their driveway. She would like Council to consider that not everyone listens when the police ask them to move their car and maybe having consequences would make people think twice about where they park.

**Ed Walter 3878 Surfside Circle**

Mr. Walter stated there needs to be uniform regulations for parking. His street has a waterline that crosses the street that will alter the parking due to hydrants on both sides of the street. He thanked everyone for the rocking chair.

**Mary Williams 10589 Florida Street**

Mrs. Williams stated the property owner behind her has not finished the fence he put up. She would like Mr. Rodic to be made aware of that.

**Al Williams 10589 Florida Street**

Mr. Williams stated the Village directed him to put in drains from his downspouts to the ditch and now one of the drains is on the other side of the fence and he cannot get to it to see if it is open.
