

**ORDINANCE NO. 41-2016**

**OFFERED BY: Mayor Alonso**

**AN ORDINANCE TO INCREASE THE HOURLY RATE OF THE REMINDERVILLE ATHLETIC CLUB EMPLOYEES, EFFECTIVE JANUARY 1, 2017.**

**WHEREAS**, Council has determined that there is good cause to increase the hourly rates of the Reminderville Athletic Club employees, now, therefore,

**BE IT ORDAINED**, by the Council of the Village of Reminderville, County of Summit, and State of Ohio:

**SECTION 1:** That the hourly rate of part-time Latchkey Leader is hereby increased to \$11.59 per hour, effective January 1, 2017.

**SECTION 2:** That the hourly rate of part-time Latchkey Aide I is hereby increased to \$9.79 per hour; Latchkey Aide II is hereby increased to \$10.04 per hour; Latchkey Aide III is hereby increased to \$10.30 per hour, effective January 1, 2017.

**SECTION 3:** That the hourly rate of part-time Front Desk Associate I is hereby increased to \$10.04 per hour; Front Desk Associate II is hereby increased to \$10.30 per hour; Front Desk Associate III is hereby increased to \$11.33 per hour, effective January 1, 2017.

**SECTION 4:** That the hourly rate of part-time Building Monitor is hereby increased to \$10.04 per hour, effective January 1, 2017.

**SECTION 5:** That the hourly rate of part-time Lifeguard I is hereby increased to \$8.96; Lifeguard II is hereby increased to \$9.53; Lifeguard III is hereby increased to \$9.79; Lifeguard IV is hereby increased to \$10.30, effective January 1, 2017.

**SECTION 6:** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the Village of Reminderville, to wit: to provide for passage prior to hiring new employees, and if this Ordinance receives the necessary number of votes, it shall take effect and be in force from and after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
