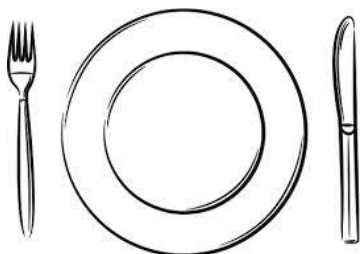


TAX ALERT

It's tax season and TAX SCAMS are on the rise. Telephone tax scams are the most popular form of scam during the tax season. The IRS respects taxpayers' rights and does NOT engage in angry, shake down, harassing, or threatening style telephone calls. The IRS has a formal process in place to assist people with their taxes. If you have any questions or concerns about the IRS or common scams, log on to IRS.gov or call the IRS at 1-800-829-1040. Here are 5 things the scammers will do but the IRS will never do: 1. The IRS will never call you and demand immediate payment. The IRS will also never call about taxes owed without first mailing you a bill. If you receive a phone call from someone claiming to work for the IRS it's probably a scam. 2. The IRS will never demand you pay taxes without giving you the opportunity to question or appeal the amount they say you owe. 3. The IRS will never require you to use a specific payment method for your taxes such as a prepaid debit card. 4. The IRS will never ask for credit card or debit card numbers over the phone. 5. The IRS will never threaten to bring in local law enforcement officials to have you arrested for not paying your taxes. The IRS will not threaten you with an arrest warrant or tell you an arrest warrant has been issued for you. Remember, if someone calls you and states they are from the Internal Revenue Service, NEVER give them any personal information such as your date of birth or social security number. Also remember the IRS does not use unsolicited email, text message, or any social media to discuss your personal tax issues. 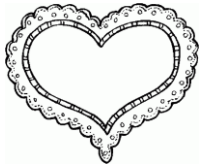
