## 2024 OHIO TOTAL SOLAR ECLIPSE

**On April 8, 2024,** a total solar eclipse will cross North America passing over Mexico, the United States, and Canada. The eclipse will travel across Ohio from southwest to northeast. On this date, people within a 124-mile-wide band in the State of Ohio will experience a total solar eclipse. This will be an exciting celestial event as total solar eclipses are rare. Areas in Ohio outside the path of totality will experience a partial eclipse. The last total solar eclipse visible in Ohio was 1806. The next total solar eclipse in Ohio will be in 2099! A total solar eclipse occurs when the moon appears to totally obscure the sun. It is not safe to look directly at the sun's rays, even if the sun is partially obscured. The only safe way to look at a partial eclipse is with eclipse glasses or hand-held solar viewers. When the moon completely blocks the visible surface of the sun during a total solar eclipse, viewers can remove their eclipse glasses until the end of the total eclipse.

CLEVELAND Area: Start of partial eclipse: 1:59pm Start of total eclipse: 3:13pm Maximum eclipse: 3:15pm End of total eclipse: 3:17pm End of partial eclipse: 4:29pm Ohio's accessibility – within a day's drive for 70% of the nation's population – makes it a hot spot for eclipse chasers. Summit County is expecting a visitor surge doubling or tripling populations in some communities and national parks. Since this is Ohio, there is a strong likelihood of clouds or rain that day. You may not be able to see the eclipse but you will experience the darkness.

Pick up a free pair of eclipse glasses at Reminderville City Hall starting on March 15. (While supplies last!)
