Mayor's Report

Mayor Alonso reported he is the new President of the Summit, Portage, and Stark County Mayors Association. He hopes to keep Reminderville in the forefront.

Law Director

Mr. Carpenter reported he proposed changes to include provisions that the Village could use the rights to escrow if the jobs weren't completed in Herrington. He's waiting to hear back about the updated copy.

Engineering

Mr. Bowlin reported the proposed Nautilus Trail East change order will replace the white topping of the street with full removal, stabilization of base, and new 7" concrete roadway. Herrington Phase 6 asphalt pavement is 75% complete and linear grading is 90% complete. Nautilus Trail East waterline replacement is 85% complete. He continued that the Village issued 56 new home permits in 2013. Builders are projecting similar numbers for 2014. The site plan visit for the rec center went well. No one had questions on site but they will send any questions to Mr. Esser.

Fiscal Officer

Ms. Wordell reported there were six Design/Build teams that submitted proposals, they shortlisted five of them. She had copies of the estimate of the advertising for the JEDD on the back page. Mr. DiCarlo reported they wanted to do this to be more visible. The price is \$2,650.00. Ms. Wordell continued her report that the Finance Committee suggested not paying the past due bill from the JEDD until they can provide more documentation of what is owed.

Chief Buck reported the dog on the legislation will be purchased out of the seizure proceeds of a drug case from a few years ago so it will not cost tax payers.
