Call to Order

Approval of Minutes

Mayor's Report

Mayor Alonso reported there was discussion at his mayors' meeting about the municipal income tax. The Village uses RITA right now and there is talk of doing a centralized state-wide way of collecting taxes.

Law Director

Mr. Carpenter stated one agency handling all of the taxing could be a problem. The Village uses Aurora's zip code and some residents actually put Aurora as their city on their taxes and that could create a mess.

Engineering

Mr. Bowlin reported the Tradewinds parking lot project at the pool is going to the Planning Commission. They are changing from asphalt to concrete and adding

drainage. Resolution 79 is working with Aurora on Aurora Lake Road. The resolution is for the surveying cost. Mr. Bowlin is expecting to receive the response for issuance of permits for the senior apartment complex. Conrad's will be going to the Planning Commission to add on a carwash. The remainder of Phase 7 for Herrington has not been submitted for final approval at this time. Phase 4 drains need additional drawings and work to be completed on three houses.
