Call to Order

I would just like a layman's explanation of the wording in the resolution about the recreation center where it says, Issue of the sale of over \$6 million worth of notes in anticipation of the issuance of income tax revenue laws. What does that mean? I'm particularly concerned about the income tax revenue laws.

Mayor Alonso replied it is the same process that they did with the street dedications, it goes out to bonds. It is how the Village is run on a daily basis. It does not mean raising taxes. If rec center memberships do not cover the payments, it would be taken out of the surplus in the general fund. It is the same

way the Village uses the general fund to cover things like the fire department when it became 24-hour, no taxes were raised.
