# John Steins Polaris Engineering 34600 Chardon Road

Speaking on behalf of Clover Construction, we are here presenting a 95-unit senior apartment facility located on Kendal Lane. I brought with me the landscape plan and a copy of the photometric plan. We did minimize the lighting on the backside of the building just to minimize some of the visual feasance to

the residential development behind. We did provide one pole by the back parking for safety reasons. The landscaping along the front parking of the building and when you're driving along Kendal, the parking sets a couple feet below the road. That in addition to the pine trees that are presented should give ample screening. We are wrapping up the loose ends and we don't see any hurdles in finalizing the plans. Everything seems to be moving along. We were looking to have approval tonight, but if you could have a special meeting so my client can move forward in this process with acquiring the land and finalizing the project to present to ARB. We are proceeding pretty quickly and our client is very excited.

## Johnnie Reed 4175 Morley Drive

With the plans you're referring to, are there any minority requirements as far as the landscaping or (inaudible)?

Mr. Steins: Not that I'm aware of.

## Al Williams 10589 Florida Street

Do you have floor plans available?

**Mr. Steins:** Sample floor plans can be provided. From what they developed in the past, they just worked the building to keep it traditional. Unit floor plans I can provide, but architectural plans we're still weeks out.

**Mr. Williams:** I have some concern about the restroom since there's only one and the lack of a bathtub being in there, even though you have a shower stall and (inaudible) and the size of the stools that you're using. For seniors, the chair-height stool is much more comfortable than the one you're (inaudible) off the floor which is normally what you use. That's what they put in a normal home, I don't know if that's what you're putting in. Those are the two concerns I have.

Mr. Kondik asked how many parking spaces. Mr. Steins replied 123. Mayor Alonso added that they will have their own bus that will take the senior apartment residents places they need to go.
