#### Joe Burian 10557 Florida Street

Mr. Burian commended Council for all they've done for progress in the Village. He wanted to discuss the drainage issue on Florida Street. He sold his land next to his house to the Village to be used for draining purposes. He stated he was then shown plans from the Village engineering firm at the time that were not the same plans as what was shown to and voted on by Council. He then stated the residents on his side of the street are all experiencing flooding problems in their yards due to that poor planning. He is hoping the current Village engineering firm will resolve the drainage problem and keep an open discussion with residents. Mr. Molina asked Mr. Bowlin to look into this issue and try to find the old plans that Mr. Burian is talking about.

Mr. Burian also commented that he thinks the prescription pill drop box is a good idea.
