

# Village of Reminderville Council Meeting August 11, 2015

#### Call to Order

### **Approval of Minutes**

### **Larry Turoczy 3521 Castaway Cove**

Mr. Turoczy stated in 2007 and 2008, the roads were terrible and the Village needed majority of votes to take over the roads. He spent two years walking and getting signatures. He was then assessed and nothing has been done to his

street. He was assessed \$7,000.00. He wanted to know why a new road hasn't been put in. He feels if a new road is not going to be put in, he would like his money back. Mayor Alonso replied he will speak with Mr. Esser about it.

### **Bill Jones 3565 Castaway Cove**

Mr. Jones stated he moved to Reminderville in November 2009. There was a prior coat of asphalt but there was never a second coat. He asked Mr. Scaffide about getting a concrete road. Mr. Scaffide responded that after speaking with administration, there was no response about concrete or asphalt. Mayor Alonso commented there was never a promise of concrete for every street. It would depend on stabilization. The assessment was for street dedication for the Village to take care of the road maintenance. Mr. Jones wanted to know why concrete was done for Outrigger and was not done for Castaway even though they all paid the same assessment. Mayor Alonso replied he will speak with Mr. Esser about it. He then explained street dedication is dependent upon the street already meeting Village standards. Council at the time decided to dedicate even though Aurora Shores streets were not up to standards. The reason was because the streets were put in before the standards were even in place. Council at the time also determined how the assessments would be divided up between the property owners in Aurora Shores. Mr. Jones would like to see the formulation for how the assessments were made when Council approved it.

#### Al Williams 10589 Florida Street

Mr. Williams stated he is glad the Village is getting a second opinion on the ditch on Florida. He then stated the Mayor of Aurora had said in the past she can't control what Bainbridge does regarding the flooding issues in Aurora and Reminderville, however she just recently stated that she will now speak with Bainbridge to see if anything can be done for flooding control.
