Call to Order

Meeting was called to order by Mayor Alonso at 8:01pm

Approval of Minutes

Mr. DiCarlo moved to approve minutes from August 12, 2014. Mr. Molina seconded. All in favor.

Mike Abamanti Crossings, Secretary of HOA

In a way, what I came here to say tonight is unneeded as of a short time ago; the resolution for the dedication of the streets was tabled for many months and I came in part to see if there was anything that could be done to, that we as a board could offer to get it off the table. Apparently, that has now happened. I'm

not sure why it was tabled for such a long time, there were at least two other subdivisions that were dedicated and I'm assuming that Crossings will be evaluated by the same criteria they were and you will tell us what you need from us to help with the process.

Mary Williams 10589 Florida Street

We're really enjoying the flowers, and the baskets, and the hanging plants and I know we have a little insignificant sign on the north end and I know the reasons why but it would be nice if next year, they could at least dig up the ground around the sign and plant a few flowers there.

Mayor Alonso replied next year they will be getting a new sign.

Al Williams 10589 Florida Street

I'm just curious when the repairs will happen on Glenwood (inaudible).

Mr. Esser replied he would speak with Mr. Scaffide.

Mr. Williams continued: the cracked sealing on north Florida, we have tar all over the road, I'm wondering if anyone is going to see that the sealing is fixed before winter.

Mr. Esser replied he would take a look at it.

Mr. Williams continued: the speed at the roundabout -

Mayor Alonso stated the speed limit is 15 mph at the roundabout.

Mr. Williams continued: with all the trees and things there, I like the trees don't get me wrong, but when they're coming up Glenwood and you're coming up the other side of Glenwood and you watch to see when you can go into the roundabout and there's somebody coming up 35-40 mph, you don't see them until they're ready to hit you as you're pulling out from the other side. It's just impossible to see, if they're coming too fast, when to pull out.

Mayor Alonso replied the trees are there so you don't focus on who is coming down Glenwood or else you would miss the person entering from Liberty. He suggested Chief Buck put his little instrument on the roundabout.
