My first question would be to Mr. Carpenter, "Through Trucks Prohibited", what does that mean?

Mr. Carpenter replied trucks over a certain weight cannot drive through the Village without making a stop or delivery of some kind. If they do, they can be fined.

Ms. Radecky: The reason I bring this up is there is a sign at 43 and Aurora Lake Road and then there is a weight limit sign 500 feet from the bridge on Nautilus. I

saw a flatbed, 48', loaded with machinery going over the bridge. Trucks can't stop when they see the sign right at the bridge and back up all the way to 43.

There was a discussion that this is something to look into since it's difficult to enforce due to the small number of officers patrolling.

Ms. Radecky: All I'm saying, wouldn't it be more logical to put something up before they get to the bridge?
