

RESOLUTION NO. 50-2017

A RESOLUTION TO AWARD A CONTRACT TO TRAX CONSTRUCTION COMPANY FOR THE NAUTILUS TRAIL WEST RECONSTRUCTION & WATERLINE IMPROVEMENT PROJECT IN AN AMOUNT NOT TO EXCEED TWO MILLION SEVENTY-EIGHT THOUSAND SEVEN HUNDRED EIGHTY-NINE AND 55/100 DOLLARS (\$2,078,789.55), AND DECLARING AN EMERGENCY.

WHEREAS, Council authorized the Village Engineer to solicit bids for the Nautilus Trail West Reconstruction & Waterline Improvement Project, and

WHEREAS, the bids were advertised and opened pursuant to Ohio law, and

WHEREAS, the Village Engineer, after reviewing such bids, has determined that Trax Construction Company has submitted the lowest and best bid and, thus, recommends that a contract to complete such Project be awarded to Trax Construction Company, and

WHEREAS, Council finds good cause to accept the recommendation of the Village Engineer, now, therefore,

BE IT RESOLVED, by the Council of the Village of Reminderville, County of Summit, and State of Ohio:

SECTION 1: That Trax Construction Company is hereby awarded a contract to perform and complete the Nautilus Trail West Reconstruction & Waterline Improvement Project in an amount not to exceed Two Million Seventy-eight Thousand Seven Hundred Eighty-nine and 55/100 Dollars (\$2,078,789.55).

SECTION 2: That a copy of Trax Construction Company's bid is attached hereto and made a part hereof.

SECTION 3: That the Mayor is hereby authorized to execute a contract with Trax Construction Company for the Project.

SECTION 4: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the Village of Reminderville, to wit: to insure commencement at the earliest possible time, and if this Resolution receives the necessary number of votes, it shall take effect and be in force from and after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
