

A RESOLUTION TO DECLARE THE NECESSITY FOR REPLACING THE TAX LEVY IN EXCESS OF THE TEN MILL LIMITATION FOR THE PURPOSE OF STREET MAINTENANCE AND REPAIR, AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the Village of Reminderville has determined that the amount of taxes which may be raised, within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of the Village of Reminderville, and

WHEREAS, pursuant to Ohio Revised Code, Section 5705.19(G), it is necessary to levy a tax in excess of the ten mill limitation for the general construction, reconstruction and repair of streets, roads, and bridges within the Village, now, therefore,

BE IT RESOLVED, by the Council of the Village of Reminderville, County of Summit, and State of Ohio:

SECTION 1: That it is necessary to replace the tax levy in excess of the ten mill limitation for the benefit of the Village of Reminderville at a rate not exceeding 3.0 mills for each \$1.00 of valuation, which amounts to \$3.00 for each \$1,000.00 of valuation, for a period of five years, such levy being effective for the 2018 tax year.

SECTION 2: That the question of replacing such additional taxes shall be submitted to the electors of the Village of Reminderville at the general election to be held at the usual voting places within said Village of Reminderville on or about the 8th day of May, 2018.

SECTION 3: That the replacement of said levy shall be extended on the tax list at the earliest time possible next preceding the election, if a majority of the electors voting thereon vote it favor thereof.

SECTION 4: That the Village Fiscal Officer is hereby directed to certify a copy of this Resolution to the Board of Elections, Summit County, Ohio, as provided by law, and notify the Board of Elections to cause notice of election on the question of levying such tax to be given as required by law.

SECTION 5: That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the Village Reminderville, to wit: in order to perfect filing within the time period required by law, and if this Resolution receives the necessary number of votes, it shall take effect and be in force from and after its passage; otherwise it shall take effect and be in force from and after the earliest period allowed by law.
