**Call to Order**

**Approval of Minutes**

Mr. DiCarlo moved to approve the minutes from July 11, 2017. Mr. Petrovich seconded. All in favor.

**Dan Elder Maryland Street**

Mr. Elder stated the culvert is covered up and the ditch behind his house needs cleaned out. He feels when they redid Maryland and put in two sewers at the end of the street, they should have put on in the middle to help with the flooding. The water from Aurora down California goes to his property. Are the ditches the Village's responsibility or the home owner's? Mayor Alonso stated it is the property owner's responsibility but he will instruct the service guys to clean it out.

**Mary Williams 10589 Florida Street**

Mrs. Williams asked about the timeline for the outlot parcel building construction. Mayor Alonso said they should be starting soon; they were just sent the zoning approval for their financing.

**Geoffrey Gannon 10050 Pirates Trail**

Mr. Gannon stated his property backs up to Liberty Park and there were retention ponds supposedly put in Liberty Ledges and for the past two months he has had major flooding in the back creek. Mayor Alonso said they put in culverts years ago to help with the flooding but it is starting to back up again; he sent Mr. Esser over to look at the issue.

**Chris Boron 3809 Nautilus Trail**

Mr. Boron stated he keeps his ditch cleaned out and he would like to know who polices that the ditches get cleaned out by home owners. Mayor Alonso said Aurora Shores is a private entity and they would have to do that.
