

**AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF REMINDERVILLE, OHIO, AND DECLARING AN EMERGENCY.**

**WHEREAS**, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of Reminderville, Ohio;

**BE IT ORDAINED**, by the Council of the Village of Reminderville, County of Summit, and State of Ohio:

**SECTION 1:** That the editing, arrangement and numbering of those ordinances and resolutions enacted by Council from November 4, 2014 to November 3, 2015, as listed in the Comparative Section Table, are hereby approved and adopted as printed in the 2016 Replacement Pages to the Codified Ordinances so as to achieve uniformity of style and classification. Notice of adoption of each new section by reference to its title shall constitute sufficient publication of new matter contained therein.

**SECTION 4:** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the Village of Reminderville, to wit: to keep Reminderville laws current with State provisions, and if this Ordinance receives the necessary number of votes, it shall take effect and be in force from and after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
