**A RESOLUTION TO HIRE INDEPENDENT CONTRACTORS AS FITNESS INSTRUCTORS FOR THE REMINDERVILLE ATHLETIC CLUB, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Athletic Director has recommended hiring independent contractors as fitness instructors for the Reminderville Athletic Club, and

**WHEREAS**, Council finds good cause to accept the recommendation of the Athletic Director, now, therefore,

**BE IT RESOLVED**, by the Council of the Village of Reminderville, County of Summit, and State of Ohio:

**SECTION 1:** That Allison Taylor is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Barre, effective July 1, 2018 through December 31, 2018, and to be paid \$24.00 per class, and

**SECTION 2:** That Elizabeth Lear is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Yoga, effective July 1, 2018 through December 31, 2018, and to be paid \$22.00 per class, and

**SECTION 3:** That Michelle Titus is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Zumba, effective July 1, 2018 through December 31, 2018, and to be paid \$27.00 per class, and

**SECTION 4:** That Pamela Miller is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Seniors Line Dancing, effective July 1, 2018 through December 31, 2018, and to be paid \$3/per participant, and

**SECTION 5:** That Paula McKenzie is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Silver Sneakers and Barre, effective July 1, 2018 through December 31, 2018, and to be paid \$24.00 per class, and

**SECTION 6:** That Stacey O'Keefe is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct 200/20/20, Silver Sneakers and Boot Camp, effective July 1, 2018 through December 31, 2018, and to be paid \$24.00 per class, and

**SECTION 7:** That Tim Carney is hereby hired as an independent contractor for the Reminderville Athletic Club to instruct Boom, effective July 1, 2018 through December 31, 2018, and to be paid \$27.00 per class, and

**SECTION 8:**That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the Village of Reminderville, to wit: to insure immediately placement, and if this Resolution receives the necessary number of votes, it shall take effect and be in force from and after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
