**Call to Order**

**Approval of Minutes**

Ms. Kovach moved to approve minutes from April 24, 2018. Mr. Hoffmann seconded. All in favor.

Mr. Wiggins moved to accept the financial reports. Mr. Petrovich seconded. All in favor.

**Kim Suter 9918 Pebble Beach Cove**

Ms. Suter commented that the new rule about parking on the street does not take into account when your driveway is being done and you have to park on the street. She would like Council to look into allowing permits for temporary parking on the street. Mr. Carpenter said she can file an appeal and give a hardship reason. Ms. Suter said Mayor Alonso helped her by talking to a neighbor and got permission for her to park in their driveway. Ms. Kovach asked if there was a temporary parking ordinance. Chief Buck said there is a temporary parking area in the gravel lot next to the police department. They can park on their grass or talk to their neighbor. The problem is one person wants to park on the street and

other neighbors call and complain. Mr. Carpenter said it is a rule. It applies to everyone. If you start to make exceptions for many, then the rule is worthless. The rule is to assist the Village as a whole. Look for other arrangements.

**Josh Ruck 3463 Shadow Ledge**

Mr. Ruck commented there are several homes in Liberty Ledges getting their driveways poured. Ryan Homes said they could park on the streets. He called the police department and was not given permission to park on the street. He parked on the street while out of town and received tickets. Ryan Homes then made a temporary parking lot for the residents but he feels it is too far away and a struggle for his wife, who has injuries, and a toddler. He would like to be able to make a request with a timeline to be able to park on the street for such circumstances. Chief Buck commented that he spoke with Mr. Ruck and told him he could not park his car there and gave him an extra day to get it moved. He receives calls that people cannot get around the cul-de-sac when someone is parked there. He also stated the residents got their occupancy permits before their driveways were done. Mr. Ruck said he was out of town already and could not move his car. Mr. Carpenter suggested appealing the ticket with his defense. He can appeal even if he already paid it. Ms. Kovach feels this is not why they set up the parking bureau. She thought it was for repeat offenders and people who don't live in the Village. She thinks if a resident calls the police department, they should be given permission to park on the street. Mr. Carpenter said there can't be a law that only applies to out-of-towners. Mr. Petrovich said there is an appeal process because there are exceptions. Ms. Kovach feels they shouldn't have gotten the ticket in the first place. Mr. Wiggins said the police department also has to think of each road as to width and if emergency vehicles can get through. Mr. Hoffmann stated people can talk to their neighbors to help each other as well.

**RESOLUTION 51-2018:** A RESOLUTION TO HIRE AMANDA VANDERVORT, JULIA VYDUSH, HOLLY HOFFMAN, BLAKE CARNAHAN, AND SAVANNAH McKEE AS SEASONAL PART-TIME SUMMER CAMP COUNSELORS AT THE REMINDERVILLE ATHLETIC CLUB TO BE PAID AT THE RATE OF NINE AND 25/100 DOLLARS (\$9.25) PER HOUR, AND DECLARING AN EMERGENCY. 1<sup>st</sup> Reading. *Alonso*

### **Old Business**

Mr. Wiggins asked for a status on a permanent pump for the Shores. It will cost \$40,000-70,000 for the pump rental plus costs for steel plates and hoses being replaced because people drive over them. Mayor Alonso told Dave Krock to start engineering the permanent pump. The cost could be \$250,000. Mr. Wiggins stated the Finance Committee feels at the rate they're expending funds and the rate they're gaining funds, it should be considered. He also talked to Aurora Shores HOA president Tyson Dinda and was told their board of trustees do not want to help and give permission to allow water to flow to the lake from California. He asked to have a meeting and also offered to hire a separate engineer to do a study. He has talked to the board numerous times over the years. He said Council is welcome to talk to the board at one of their meetings. Ms. Kovach feels the issue is the sediment. Mayor Alonso said the pipe is enclosed. He said the water from Bainbridge comes through Aurora and into

Reminderville. It was supposed to stay in Aurora. When the park system came in, they recharged the wetlands, the water came in Reminderville. New culverts were put in. There is no waterflow between Reminderville and the park on route 82. The Village gets water coming in from surrounding communities and no where to dump it. The outlets behind Ensign Cove are three feet below the channel, no where for the water to go. They try to clean it up as best they can. Ms. Kovach asked if they could go to the Shores HOA meeting. Mayor Alonso said he requested a meeting with them and they haven't responded.
