Mr. Gorog introduced himself to Council. He is working as the community representative for OHM in Reminderville. He reported the Nautilus Trail project is still on schedule to be completed at the end of October. The bid opening for the N. Surfside pavement project is October 4. The final review has been submitted for the California Street Reconstruction Project and they will be preparing bid documents. OHM and Mayor Alonso will be meeting to complete the 5 and 10-year plan for the Village. Mr. Gorog has also been performing engineering field visits regarding resident issues.
