

ORDINANCE NO. 04-2020

AN ORDINANCE TO AMEND ORDINANCE 23-2019, THE SALARY PROVISIONS OF FIRE DEPARTMENT PERSONNEL, TO REFLECT ACCURATE AMOUNTS, AND DECLARING AN EMERGENCY.

WHEREAS, Council has determined that there is good cause to amend the previous salary increases of Fire Department personnel to account for accurate amounts, therefore,

NOW, BE IT ORDAINED by the Council of the Village of Reminderville, County of Summit, State of Ohio:

SECTION 1. That the annual salary for the Fire Chief shall be \$45,170.76 plus \$1,420.56 for longevity totaling \$46,591.32, effective January 12, 2020.

SECTION 2. All promotions shall be reviewed and approved by Council.

SECTION 3. That the annual salary for the Assistant Fire Chief shall be \$38,004.10 plus \$671.93 for longevity totaling \$38,676.03, effective January 12, 2020.

SECTION 4. That the hourly rate of pay for a Captain shall be \$26.31, effective January 12, 2020.

SECTION 5. That the hourly rate of pay for a Lieutenant shall be \$23.92, effective January 12, 2020.

SECTION 6. That the hourly rate of pay for a Firefighter/Paramedic shall be \$21.74, effective January 12, 2020.

SECTION 7. That the hourly rate of pay for a Firefighter/EMT shall be \$18.77, effective January 12, 2020.

SECTION 8. The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 9. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the Village of Reminderville, to wit: to provide for accurate amounts, and if this Ordinance receives the necessary number of votes, it shall take effect and be in force after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
