

**RESOLUTION NO. 11-2020**

**A RESOLUTION AUTHORIZING COUNCIL MEMBER BECKI KOVACH TO MAKE APPLICATION ON BEHALF OF THE VILLAGE OF REMINDERVILLE FOR A NATUREWORKS GRANT THROUGH THE OHIO DEPARTMENT OF NATURAL RESOURCES (ODNR) FOR IMPROVEMENTS TO RAY WILLIAMS PARK; FURTHER AUTHORIZING MAYOR ALONSO TO ACCEPT THE GRANT, IF AWARDED, AND TO EXECUTE ANY CONTRACTS WITH ODNR AS RELATED TO THESE IMPROVEMENTS.**

**WHEREAS**, the State of Ohio through the Ohio Department of Natural Resources (ODNR) administers financial assistance for public recreation purposes through the State of Ohio NatureWorks Grant Program, and

**WHEREAS**, the Village of Reminderville, in an effort to enhance recreational facilities available at Ray Williams park, desires the financial assistance of the NatureWorks Grant Program, and is eligible to apply for a project up to \$150,000.00 and receive up to 75% reimbursement, and

**WHEREAS**, it is the desire of this Council to authorize Council member Becki Kovach to apply for said NatureWorks grant from ODNR; to further authorize Mayor Alonso to accept the grant if awarded, and to execute a contract with ODNR if required; and to authorize Council member Becki Kovach to execute all other non-contract documents necessary to effectuate receipt of the grant, and

**NOW, BE IT RESOLVED** by the Council of the Village of Reminderville, County of Summit, State of Ohio:

**SECTION 1.** That Council member Becki Kovach is hereby authorized to apply for a NatureWorks Grant from the State of Ohio Department of Natural Resources (ODNR) and that this Council obligates the funds required to complete the project and become eligible for reimbursement under the terms of the NatureWorks Grant Program, as appropriated pursuant to separate ordinance.

**SECTION 2.** That Mayor Alonso is authorized to accept said grant, if awarded, on behalf of the Village of Reminderville and to execute a contract with ODNR, if required; and that Council member Becki Kovach is authorized to execute all other non-contract documents necessary to effectuate receipt of the grant..

**SECTION 3.** The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

**SECTION 4.** That this Resolution shall take effect and be in force from and after the earliest period allowed by law.
