A RESOLUTION TO HIRE INDEPENDENT CONTRACTORS AS PERSONAL TRAINERS AND FITNESS INSTRUCTORS FOR THE REMINDERVILLE ATHLETIC CLUB AND DECLARING AN EMERGENCY.

WHEREAS, the Director of the Reminderville Athletic Club has recommended hiring independent contractors as personal trainers and fitness instructors for the Reminderville Athletic Club, and

WHEREAS, Council finds good cause to accept the recommendation of the Director of the Reminderville Athletic Club, and therefore

NOW, BE IT RESOLVED by the Council of the Village of Reminderville, County of Summit, State of Ohio:

SECTION 1. That Brenda O'Hara is hereby hired as an independent contractor for the Reminderville Athletic Club to be a Personal Trainer, Nutrition Coach, and teach Bootcamp, effective July 1, 2020 through December 31, 2020, and will accept payments from clients and pay the Reminderville Athletic Club 15% of the charged rate per hour/per client, and

SECTION 2. That Brian White is hereby hired as an independent contractor for the Reminderville Athletic Club to be a Personal Trainer effective July 1, 2020 through December 31, 2020, and will accept payments from clients and pay the Reminderville Athletic Club 15% of the charged rate per hour/per client, and

SECTION 3. That Stacey O'Keefe is hereby hired as an independent contractor for the Reminderville Athletic Club to be a Personal Trainer effective July 1, 2020 through December 31, 2020, and will accept payments from clients and pay the Reminderville Athletic Club 7% of the charged rate per hour/per client, and

SECTION 4. That Andrew Kaplan is hereby hired as an independent contractor for the Reminderville Athletic Club to be a Personal Trainer effective July 1, 2020 through December 31, 2020, and will accept payments from clients and pay the Reminderville Athletic Club 15% of the charged rate per hour/per client, and

SECTION 5. The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 6. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the Village of Reminderville, to wit: to ensure immediate placement, and if this Resolution receives the necessary number of votes, it shall take effect and be in force from and after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
