A RESOLUTION TO HIRE CHELSEA KORDA AS AN INDEPENDENT CONTRACTOR FOR THE REMINDERVILLE ATHLETIC CLUB, AND DECLARING AN EMERGENCY.

WHEREAS, the Athletic Director has recommended hiring independent contractors as personal trainers for the Reminderville Athletic Club, and

WHEREAS, Council finds good cause to accept the recommendation of the Athletic Director, now, therefore,

BE IT RESOLVED, by the Council of the Village of Reminderville, County of Summit, and State of Ohio:

SECTION 1: ~~That Brian White is hereby hired as an independent contractor for the Reminderville Athletic Club to be a Personal Trainer, effective July 1, 2020 through December 31, 2020, and will accept payments from clients and pay the Reminderville Athletic Club 50% of the charged rate per hour/per client, and~~

SECTION 2: ~~That Brenda O'Hara is hereby hired as an independent contractor for the Reminderville Athletic Club to be a Personal Trainer, Nutrition Coach, and Bootcamp effective July 1, 2020 through December 31, 2020, and will accept payments from clients and pay the Reminderville Athletic Club 50% of the charged rate per hour/per client, and~~

SECTION 3: ~~That Stacey O'Keefe is hereby hired as an independent contractor for the Reminderville Athletic Club to be a Personal Trainer, effective July 1, 2020 through December 31, 2020, and will accept payments from clients and pay the Reminderville Athletic Club 50% of the charged rate per hour/per client, and~~

SECTION 4: ~~That Andrew Kaplan is hereby hired as an independent contractor for the Reminderville Athletic Club to be a Personal Trainer, effective July 1, 2020 through December 31, 2020, and will accept payments from clients and pay the Reminderville Athletic Club 50% of the charged rate per hour/per client, and~~

SECTION 5: That Chelsea Korda is hereby hired as an independent contractor for the Reminderville Athletic Club to furnish one-on-one volleyball lessons, effective July 1, 2020 through December 31, 2020, and will accept payments from clients and pay the Reminderville Athletic Club 50% of the charged rate per hour/per client, and

SECTION 6:That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the Village of Reminderville, to wit: to insure immediately placement, and if this Resolution receives the necessary number of votes, it shall take effect and be in force from and after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
