

**RESOLUTION NO. 59-2020**

**A RESOLUTION TO ACCEPT THE RECOMMENDATION OF OHM ADVISORS TO ACCEPT THE PROPOSAL OF TRI MOR CONSTRUCTION TO PERFORM EMERGENCY REPAIRS ON NAUTILUS TRAIL IN AN AMOUNT NOT TO EXCEED TWENTY-THREE THOUSAND SIX HUNDRED FIFTY DOLLARS AND NO/100 (\$23,650.00) AND DECLARING AN EMERGENCY.**

**WHEREAS**, there are emergency repairs needed to Nautilus Trail near address 3570 Nautilus Trail in the Village, and

**WHEREAS**, OHM Advisors has received a proposal from Tri Mor Construction for the emergency repairs, and

**WHEREAS**, Council finds good cause to accept the recommendation of OHM Advisors to engage Tri Mor Construction to perform the emergency repairs, and therefore,

**NOW, BE IT RESOLVED** by the Council of the Village of Reminderville, County of Summit, State of Ohio:

**SECTION 1.** That the proposal of Tri Mor Construction for the emergency repairs to Nautilus Trail is hereby approved and accepted.

**SECTION 2.** That a copy of such proposal is attached hereto and made a part hereof.

**SECTION 3.** Council finds that appropriations are available in Fund 2902 for Engineering Services.

**SECTION 3.** The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

**SECTION 4.** That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the Village of Reminderville, to wit: to ensure commencement of the project at the earliest possible time, and if this Resolution receives the necessary number of votes, it shall take effect and be in force after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
