Anthony Garcia 10175 Pirates Trail

Mr. Garcia said his home was one that flooded with sewage. He thanked Mayor Alonso for being out in the storm with him trying to find the problem and for helping to deal with Summit County DOSSS. He would like to help solve the issues with Summit County for all of the residents who had sewage back-up. DOSSS is telling residents the lines are clear but Mr. Garcia would like to see them better inspected and shown proof they are clear. He would like to know when they had their last camera inspection and if they are going to take responsibility for their lines. Mayor Alonso said he is meeting with DOSSS and OHM and will get more information.

Ron Farleman 3648 Nautilus Trail

Mr. Farleman said he was coming home in the storm because his basement was backing up with sewage. He turned in to the Shores and was stopped by a police officer who told him he couldn't go through and he would be arrested for failing to obey a lawful order. Mr. Farleman was able to get to his home and plug the drain. His insurance will not cover the furniture and items that were destroyed. He is upset and wants to know who is to blame. Mayor Alonso said that is what they are working on to find out how the storm water infiltrated the waste water. Mr. Farleman asked if it is standard procedure for an officer to threaten to arrest you if he doesn't agree with what you are doing. Mayor Alonso said if the officer was there and felt you could endanger yourself or others, that is standard procedure but you were not arrested. He suggested he contact Chief Berquist and speak with him.
