## AN ORDINANCE TO AMEND THE SALARY PROVISIONS OF FIRE DEPARTMENT PERSONNEL, EFFECTIVE DECEMBER 27, 2020, AND DECLARING AN EMERGENCY.

**WHEREAS,** Council has determined that there is good cause to increase the salaries of Fire Department personnel, therefore,

**NOW, BE IT ORDAINED** by the Council of the Village of Reminderville, County of Summit, State of Ohio:

**SECTION 1.** That the annual salary for the Fire Chief shall be \$46,525.88 plus \$1,420.56 for longevity totaling \$47,946.44, effective December 27, 2020.

**SECTION 2.** All promotions shall be reviewed and approved by Council.

**SECTION 3.** That the annual salary for the Assistant Fire Chief shall be \$39,144.22 plus \$671.93 for longevity totaling \$39,816.15, effective December 27, 2020.

**SECTION 4.** That the hourly rate of pay for a Captain shall be \$27.10, effective December 27, 2020.

**SECTION 5.** That the hourly rate of pay for a Lieutenant shall be \$24.64, effective December 27, 2020.

**SECTION 6.** That the hourly rate of pay for a Firefighter/Paramedic shall be \$22.39, effective December 27, 2020.

**SECTION 7.** That the hourly rate of pay for a Firefighter/EMT shall be \$19.33, effective December 27, 2020.

**SECTION 8.** The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

**SECTION 9.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the Village of Reminderville, to wit: to provide for passage prior to hiring new employees, and if this Ordinance receives the necessary number of votes, it shall take effect and be in force after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
