Old Business

New Business

Chief Plunkett shared his opinion that Summit County is not doing a good job with the distribution of the vaccination. He feels the vaccinations should be given out by the fire departments throughout the county. They would be able to store and give out the vaccinations in a timelier manner. He welcomed Council to write to Chris Barker, head of the Summit County Department of Public Health, and Governor DeWine. Chief Berquist stated they are petitioning to get law enforcement back on the list to be vaccinated. Mayor Alonso said the Mayors Association sent letters to Governor DeWine requesting law enforcement be included in the first rounds of vaccinations.

Mr. Darrah reported the Long-Term Community Development will be applying for the EPA's NatureWorks grant to use in the playground area of the Village. They will be sending out a survey for residents to get ideas for the park area.

Mr. Gorog reported the proposal for the 2021 Paving Program has base bids and alternate bids. He also reported the OPWC engineers will be coming out in February to look at Smugglers Cove. He stated Jason Popeil from OHM will be taking over for Tom Tucker as the Village engineer.

Mayor Alonso announced there may be a coffee company coming to the plaza.
