

ORDINANCE NO. 03-2021

AN ORDINANCE TO AMEND SECTION 139.01 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF REMINDERVILLE, ENTITLED "COMPOSITION".

WHEREAS, Council has determined that there is a need to amend Section 139.01 of the Codified Ordinances, therefore;

NOW, BE IT RESOLVED by the Council of the Village of Reminderville, County of Summit, State of Ohio:

SECTION 1. That Section 139.01 of the Codified Ordinances of the Village of Reminderville which presently reads as follows:

139.01 COMPOSITION.

(a) The Police Department shall not exceed eight full-time patrolmen and/or ten part-time officers and shall consist of the following officers/employees who shall be appointed by the Mayor subject to confirmation by Council:

- (1) A Marshal who shall be designated as Chief of Police.
- (2) Captain.
- (3) Lieutenant.
- (4) Sergeant.
- (5) Officer/Detective.
- (6) Full-time patrol officer.
- (7) Part-time patrol officer.
- (8) Administrative secretary/Clerk of Court.

(b) Full Time Employees.

- (1) Works a total of 80 hours during a two week pay period.
- (2) All are non-exempt (eligible for overtime) except the Chief of Police.

(c) Part Time Employees.

- (1) May work full-time hours during the summer months and at other periods, as needed.
- (2) A part-time employee that is hired as a full-time employee shall be credited for the actual hours worked as a part-time employee as to sick leave, but not for seniority within the department.
- (3) May purchase their own medical and health insurance benefits.

shall be amended to read as follows:

139.01 COMPOSITION.

(a) The Police Department shall consist of a Chief of Police who shall be appointed by the Mayor subject to confirmation by Council.

(b) The Police Department shall consist of no more than nine (9) full-time patrolmen and Detective(s).

(c) In addition to the nine (9) full-time patrolmen and Detective(s), the following ranks and positions may be filled by appointment by the Mayor subject to confirmation by Council:

- (1) Captain.
- (2) Lieutenant.
- (3) Sergeant.
- (4) Administrative secretary/Clerk of Court.

(d) Full Time Employees.

- (1) Work a total of 80 hours during a two week pay period.
- (2) All are non-exempt (eligible for overtime) except the Chief of Police.

(e) The Police Department shall consist of no more than five (5) part-time patrolmen.

- (1) Part-time patrolmen may work full-time hours during the summer months and at other periods, as needed.
- (2) May purchase their own medical and health insurance benefits.

SECTION 2. The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 3. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
