AN ORDINANCE TO AMEND SECTION 1335.03 OF THE CODIFIED ORDINANCES OF THE VILLAGE OF REMINDERVILLE ENTITLED "RENEWAL OF REGISTRATION" AND DECLARING AN EMERGENCY.

WHEREAS, Council has determined that there is a need to amend Section 1335.03 of the Codified Ordinances, and therefore,

NOW, BE IT RESOLVED by the Council of the Village of Reminderville, County of Summit, State of Ohio:

SECTION 1. That Section 1335.03 of the Codified Ordinances of the Village of Reminderville which presently reads as follows:

1335.03 RENEWAL OF REGISTRATION.

The certificate of registration shall be valid for the calendar year in which it was issued and shall be renewed annually thereafter. Renewals must be made on or before the eighteenth day of January of the next succeeding year. Licenses are issued for a calendar year starting January 1 or any date thereafter during the year and expires December 31 of the same year. The fee is ten dollars (\$10.00) a year or for any portion thereof. A fee of ten dollars (\$10.00) shall be paid for registration at the time of the original issuance and each renewal thereafter. The fee for the general contractor shall be ten dollars (\$10.00) plus ten dollars (\$10.00) for each trade in his direct employment.

(1978 Code Sec. 801.03)

shall be amended to read as follows:

1335.03 RENEWAL OF REGISTRATION.

The certificate of registration shall be valid for the calendar year in which it was issued and shall be renewed annually thereafter. Licenses are issued for a calendar year starting January 1 or any date thereafter during the year and expires December 31 of the same year. The fee is one hundred fifty dollars (\$150.00) a year or for any portion thereof. A fee of one hundred fifty dollars (\$150.00) shall be paid for registration at the time of the original issuance and each renewal thereafter.

SECTION 2. The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 3. That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the Village of Reminderville, to wit: said amendment is for the benefit of the residents of the Village of Reminderville, and if this Resolution receives the necessary number of votes, it shall take effect and be in force after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
