**Call to Order**

Meeting was called to order by Mr. Salapski at 7:00pm

Ms. Cave is not a qualified elector of the Village of Reminderville so she cannot serve on the Charter Review Commission. Ms. Beth Pajemola is her replacement. Ms. Pajemola has a daughter and has resided in Willowbrook for 14 years. She works at Progressive as an IT manager.

**Approval of Minutes**

Mr. Montague moved to approve the minutes from March 31, 2021. Ms. Pajemola seconded. All in favor.

**Comments from the Public:** Thirty minutes' maximum time, five minutes per person. Raise your hand, state your name and address. Please remember residents have the opportunity to raise their hands and be recognized by the chair at any time during public meetings.

There were no comments from the public.

Ms. Task began the review and discussion of Articles I-VIII. There were no comments pertaining to Articles I and II. In Article III, when the term "general law" is stated, it refers to Ohio Revised Code.

Article IV pertains to Council. Ms. Task explained the Councilmanic districts were repealed by the electors in November 2012 so all of Council now serves at-large and represents all districts. It was difficult to find residents to run for a Council seat in each district. Four of the six Council members live in the Aurora Shores neighborhood. Mr. Montague commented that could lead to a communication issue between areas of the Village. He continued that the issue

includes confusion regarding the 911 dispatch center being in Twinsburg. Ms. Task explained the Village cannot have their own dispatch center which is why the Village uses Twinsburg. It is very important that the residents in Reminderville say they are in Reminderville and give their address. The calls from cell phones go to a tower in Geauga County and they do not know the streets in Reminderville like Twinsburg does. Landlines will automatically go to the correct dispatch; however, cell phone calls will not so residents have to clarify. Mr. Montague would like to know how the population has changed since the districts were repealed.

Ms. Chakkarwar asked about the Rules of Council. Ms. Task replied Village Council follows the parliamentary procedures in Robert's Rules of Order for their meeting format and rules.

Ms. Chakkarwar asked if there should be a definition of the word "bond" is Section 4.14. Ms. Task will get information from Fiscal Officer Deborah Wordell.

In reviewing Articles V, VI, VII, and VIII, it was clarified that in Article VII, the Council may establish temporary or permanent departments, boards, and/or commissions as the needs of the Municipality may require.

It was discussed that any grammatical errors found during the review can be corrected without Council approval and will be completed for the new printing of the Charter books.

Mr. Montague moved to adjourn. Ms. Chakkarwar seconded. All in favor.
