Mr. Gorog stated the paving program reports have been sent to Council to assist in discussion for roadwork in the coming years. Mr. Gorog will also be submitting for the small government grant. He also stated the Village will be receiving \$103,000 in reimbursements from Cleveland Water for the Nautilus Trail project.

Ms. Rockhill reported she contacted the warrantee company and their preferred vendor to discuss the issues with the roof at the RAC.

The Service Department submitted a report stating they have received zero applications for the part-time summer help position. It was discussed and decided to raise the pay rate to \$12 per hour for that position. The department is starting to mow and cold patch road work as needed. They have completed all damage to tree lawns from the plow trucks.

Ms. Task reported Safety Town has 25 children registered, if more come in she may have to add an extra week. Safety Town will be June 7-11 and student volunteers are always welcome. Shred Day is April 24 11:00-2:00 at Village Hall. Family Fun Day is June 19 and there will be face painters, balloon artists, Rocket Car, touch-a-truck, treats, and a petting zoo. Ms. Task thanked Mr. Gorog for being the Easter Bunny and Ms. Blayney for her help in preparing for the successful event which had 145 children coming through. She also reported the April Fool's Day goodie bag drive-thru for the seniors was a success with 58 coming through.
