Call to Order

Approval of Minutes

Mr. Wiggins moved to approve the minutes from May 11, 2021. Mr. Hoffmann seconded. All in favor.

Sandra Mullins 3675 Nautilus Trail

Ms. Mullins stated she and her husband have lived in their house in the Shores for 25 years. When their split-level home floods, it floods to the top of the 8' basement and 3 ½' on the main family room floor. They have to move items out of the house, they have lost thousands of dollars in property plus structural damage. She loves her home and community and does not want her home torn down or bought from the Village, she wants to see the flooding fixed. They have to vacate when their electrical box is under water. Mayor Alonso said he is

working on it. He started the second pump to get the water away from her house during the last rain. The leaves and silt have stopped the flow going in the other direction. The Village does not own those areas but he is trying to rectify the situation.

Anthony Garcia 101785 Pirates Trail

Mr. Garcia stated he asked the Mullins to come to the meeting to be another voice to those who are traumatized. He is looking forward to seeing the flood study. Mr. Wiggins said the study will show the facts and then it will have to be determined what others will have to do with those facts. Mayor Alonso added it is not just the Village's responsibility, it is the Shores HOA property that has been neglected over time. The Village provides branch pickup and leaf pickup yet there is still leaves, branches, furniture, home items thrown into the back ditches.

Ken Mullins 3675 Nautilus Trail

Mr. Mullins asked if the study included the engineers coming out while it was raining. Mayor Alonso replied they walked through everything during the last rain.
