

**ORDINANCE NO. 12-2021**

**OFFERED BY: Mayor Alonso**

**AN ORDINANCE PROVIDING FOR THE SUBMISSION TO THE ELECTORATE OF AMENDMENTS TO SECTIONS OF THE CHARTER RELATING TO THE ESTABLISHMENT OF COUNCILMANIC DISTRICTS.**

**WHEREAS**, in 2012, the electorate voted to amend the Charter to repeal/abolish councilmanic districts, and

**WHEREAS**, the Charter Review Commission recommends and Council desires to change the Charter to re-establish councilmanic districts, and

**WHEREAS**, Council desires to submit amendments to sections of the Charter that would effectuate the above referenced change to a vote of the electorate at the November 2, 2021 election.

**NOW, BE IT RESOLVED** by the Council of the Village of Reminderville, County of Summit, State of Ohio:

**SECTION 1.** That the Council of the Village of Reminderville hereby and herein submits for consideration by the electorate, amendments to Sections 4.02, 4.03, 4.04, 4.11, 4.13, and 4.15 to re-establish councilmanic districts within the Village. A copy of said amendment is attached hereto as Exhibit A and incorporated herein by reference.

**SECTION 2.** That the Clerk of Council is hereby directed to certify a copy of this Ordinance to the Board of Elections of Summit County, make the necessary arrangements with the Board of Elections, and give the required notice to the Village's electors for the proper placement of this Amendment on the ballot for the November 5, 2021 Election.

**SECTION 3.** That the question presented to the voters shall be as follows:

Shall Sections 4.02, 4.03, 4.04, 4.11, 4.13, and 4.15 of the Charter of the Village of Reminderville be amended to re-establish councilmanic districts.

**SECTION 4.** The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

**SECTION 5.** If this ordinance receives the necessary number of votes, it shall take effect and be in force after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
