

**RESOLUTION NO. 42-2021**

**OFFERED BY: Mayor Alonso**

**A RESOLUTION TO AWARD A CONTRACT TO RONYAK PAVING, INC. FOR THE 2021 PAVING PROGRAM BASE BID IN AN AMOUNT NOT TO EXCEED TWO - HUNDRED FORTY-ONE THOUSAND THREE-HUNDRED FORTY-TWO AND 00/100 DOLLARS (\$241,342.00), AND DECLARING AN EMERGENCY.**

**WHEREAS**, OHM has recommended there is a need for paving services for several streets in the Village of Reminderville for the year 2021, and

**WHEREAS**, Council authorized the Village Engineer to solicit bids for the 2021 Paving Program, and

**WHEREAS**, the bids were advertised and opened pursuant to Ohio law, and

**WHEREAS**, OHM has determined Ronyak Paving, Inc. has submitted the lowest and best bid and OHM has recommended to Council that they accept said bid, and

**NOW, BE IT RESOLVED** by the Council of the Village of Reminderville, County of Summit, State of Ohio:

**SECTION 1.** That the Village of Reminderville hereby awards Ronyak Paving, Inc. the project in the Village to perform paving services as reflected in their base bid in an amount not to exceed two hundred forty-one thousand three hundred forty-two dollars and 00/100 (\$241,342.00).

**SECTION 2.** That the recommendation letter from OHM is marked Exhibit "A" and made a part hereof.

**SECTION 3.** The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

**SECTION 4.** That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the Village of Reminderville, to wit: to insure the project begins at the earliest possible time, and if this Resolution receives the necessary number of votes, it shall take effect and be in force after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
