Call to Order

Approval of Minutes

Mr. Wiggins moved to approve the minutes from June 8, June 17, and July 13, 2021. Mr. Hoffmann seconded. All in favor.

Beth Pajemola 4223 Morley Drive

Ms. Pajemola stated she appreciates the feedback pertaining to the Charter Review recommendation but the recommendation is to put it on the ballot so the voters can decide, not that it be implemented by Council. The debate is not whether or not it is a good idea but should it be placed on the ballot for the voters to decide. She added how Council said they represent the whole community and a good start would be having Council representation at the HOA meetings for all neighborhoods and would be a good place to share news and talk about volunteering in the Village.

Ben Berkowitz 10556 Florida Street

Mr. Berkowitz stated in June 2020 Cleveland Water fixed a line in the street but did not repair the hole they made. It is unsafe for children playing in the street, fills with water when it rains, and is a driving hazard. It has not been repaired in over a year. He spoke about it at a Council meeting in November 2020 and nothing was done. The Village has an ordinance stating there is to be an engineer at the site while it's being fixed and another stating a penalty of \$200 per day until it is fixed. Mayor Alonso said it will be fixed by the time Florida Street gets paved.

Vincent Montague 3638 Ivy Ct

Mr. Montague stated he was on the Charter Review and he thinks the voters should have the opportunity to decide if they want districts or not. It was a close vote the last time it was on the ballot and giving them the vote will show how important it is to them or not. If they vote no, then it's no. He also said there should be safety markers on Glenwood Blvd in the walking/biking path and a marked crosswalk by the playground and police station. Mayor Alonso said striping is being done as part of the paving program. He also addressed the delay in trash pick-up lately, sometimes up to a day and a half before Kimble does it.

Anthony Garcia 10705 Pirates Trail

Mr. Garcia stated he is the chair of the Aurora Shores Flood Mitigation Committee. He has informed the residents in the Shores to not dump things in the drainage ditches and creeks and to use the branch pick-up program weeks when clearing out their yards. They will be having a presentation at the marina to discuss rain barrel training, grants to plant trees, other ideas to build awareness. They have also been kayaking down Pond Brook to Rt. 82 to measure the water depth and look for beaver dams. They have spoken with MetroParks and they agreed to help with dredging and are open for more discussions.
