**Call to Order**

**Brian Myers 10241 Smugglers Cove**

Mr. Myers stated the ravine by his house was not able to hold the water from the last rain event. He understands where the drains are being installed, he wants to know what is being done to get the water to move out once it gets to its destination. Mr. Wiggins commented the City is working with Summit County to get a new pumphouse to move the water through faster as well as plans to put in detention ponds to diminish the volume but increase the speed. In the meantime, there is going to be an additional pump added to send the water underground to move it as fast as possible. Mr. Hoffmann added there is also

the issue of residents putting grass clippings, debris, branches in the ditches. Mr. Popiel stated they are working with the Aurora Shores HOA to get the ditches better maintained. They are also adding more catch basins to get the water moving out faster.
