RESOLUTION 66-2022: A RESOLUTION TO HIRE ALLISON TAYLOR AS AN INDEPENDENT CONTRACTOR FITNESS INSTRUCTOR FOR THE REMINDERVILLE ATHLETIC CLUB, AND DECLARING AN EMERGENCY. 1st Reading. *Jeromos*
