

**ORDINANCE NO. 49-2022**

**OFFERED BY: Mayor Alonso**

**AN ORDINANCE TO PAY FULL-TIME AND PART-TIME EMPLOYEES OF THE CITY OF REMINDERVILLE A ONE-TIME INFLATION HARDSHIP REDUCTION PAYMENT, AND DECLARING AN EMERGENCY.**

**WHEREAS**, Council has determined that there is a need give all part-time and full-time employees of the City of Reminderville a one-time inflation hardship reduction payment; and therefore,

**NOW, BE IT ORDAINED** by the Council of the City of Reminderville, County of Summit, State of Ohio:

**SECTION 1.** Council hereby grants full-time and part-time employees of the City of Reminderville a one-time inflation hardship reduction payment.

**SECTION 2.** A listing of the employees and their payments is attached hereto and made a part hereof.

**SECTION 3.** The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

**SECTION 4.** That this Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the City of Reminderville, to wit: said Ordinance is for the benefit of the residents of the City of Reminderville, and if this Ordinance receives the necessary number of votes, it shall take effect and be in force after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
