

**ORDINANCE NO. 01-2023**

**OFFERED BY: Mr. DiCarlo**

**AN ORDINANCE TO TRANSFER ONE HUNDRED THOUSAND DOLLARS AND 00/100 (\$100,000.00) FROM THE VR JEDD FUND (2073) TO THE PARKS AND REC FUND (2041), AND TO TRANSFER FORTY-SEVEN THOUSAND TWO-HUNDRED TWENTY-EIGHT DOLLARS AND 00/100 (\$47,228.00) FROM THE GENERAL FUND (1000) TO THE OPWC FUND (3901), AND DECLARING AN EMERGENCY.**

**WHEREAS**, Council finds good cause to authorize the City Finance Director to make supplemental appropriations and transfers to reflect adjustments which were previously approved by Council and need to occur during the current fiscal year, now, therefore,

**BE IT ORDAINED**, by the Council of the City of Reminderville, County of Summit, and State of Ohio:

**SECTION 1:** Council hereby authorizes and directs the City Finance Director to transfer one-hundred thousand dollars (\$100,000) from the VR JEDD Fund (2073) to the Parks and Rec Fund (2041), to meet budgetary requirements.

**SECTION 2:** Council hereby authorizes and directs the City Finance Director to transfer forty-seven thousand two-hundred twenty-eight dollars and 00/100 (\$47,228.00) from the general fund (1000) to the OPWC fund (3901).

**SECTION 3:** Any Ordinances or Resolutions or parts of Ordinances or Resolutions in conflict with this Ordinance are hereby repealed. Any Ordinances or Resolutions or parts of Ordinance or Resolution not in conflict with this Ordinance shall remain in full force and effect.

**SECTION 4:** This Ordinance is an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the citizens of the City of Reminderville, to wit: these funds are needed to cover expenses for the debt service payment and if this Ordinance receives the necessary number of votes, it shall take effect and be in force from and after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
