

A RESOLUTION REQUESTING AND AUTHORIZING THE SUMMIT COUNTY BOARD OF ELECTIONS TO PLACE UPON THE CITY OF REMINDERVILLE BALLOT AT THE PRIMARY ELECTION TO BE HELD ON MAY 2, 2023, THE ISSUE OF REPLACING THE TAX LEVY IN EXCESS OF THE TEN-MILL LIMITATION FOR THE PURPOSE OF STREET MAINTENANCE AND REPAIR, AND DECLARING AN EMERGENCY.

WHEREAS, the present levy for street repair and maintenance is due to expire, and

WHEREAS, Council finds that replacing the expiring levy is in the best interest of the residents of the City of Reminderville, and

WHEREAS, pursuant to O.R.C. 5705.19(G), it is necessary to levy a tax in excess of the ten-mill limitation for the general construction, reconstruction, and repair of streets, roads, and bridges within the City; now, therefore

NOW, BE IT RESOLVED by the Council of the City of Reminderville, County of Summit, State of Ohio:

SECTION 1. That the question of whether to replace the expiring tax levy in excess of the ten-mill limitation for the purpose of street maintenance and repair, is hereby directed to be submitted to a vote of the qualified electors of the City of Reminderville, Ohio, at the primary election to be held on the 2nd day of May, 2023, at the regular places of polling in said municipality between the hours set forth by the Summit County Board of Elections.

SECTION 2. That for purposes of presentation on the ballot the issue presented shall be as follows:

PROPOSED REPLACEMENT LEVY

A replacement tax for the benefit of the City of Reminderville for the purpose of general construction, reconstruction, and repair of streets, roads, and bridges within the City of Reminderville that the county auditor estimates will collect \$468,699.00 annually, at a rate not exceeding three mills (3.0) for each One Dollar (\$1.00) of taxable value, which amounts to One Hundred Five Dollars (\$105.00) for each One Hundred Thousand Dollars (\$100,000.00) of the county auditor’s appraised value, for a period of five (5) years commencing with the tax year 2023 and first due in 2024.

SECTION 3. That in the event the foregoing proposed replacement levy is approved by a majority of the electors voting thereon, it shall become effective as provided therein.

SECTION 4. That the City Finance Director is hereby directed to give notice of such proposed levy replacement through publishing or mailing as required by law.

SECTION 5. That the City Finance Director is hereby directed to certify a copy of this Resolution to the Board of Elections, Summit County, Ohio, as provided by law, and that this Resolution be, and hereby is, determined sufficient authority upon filing with the Summit County Board of Elections to cause that government body to place the herein prescribed replacement levy issue upon the City of Reminderville Ballot for the May 2, 2023 primary election and that such authority be deemed granted to the Board of Elections upon receipt of a certified copy of this Resolution from the City Finance Director.

SECTION 5. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the City of Reminderville to wit: to perfect filing within the time period required by law. If this Resolution receives the necessary number of votes, it shall take effect and be in force after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
