

**RESOLUTION NO. 49-2023**

**A RESOLUTION TO TRANSITION ERIC JONES, NICHOLAS ZAGORSKI, AND STEEL FARKAS TO FULL-TIME FIREFIGHTERS WITH THE CITY OF REMINDERVILLE FIRE DEPARTMENT, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the Fire Chief has recommended the hiring of full-time firefighters for Reminderville Fire Department based on the current community needs, and

**WHEREAS**, the Fire Chief has determined that Eric Jones, Nicholas Zagorski, and Steel Farkas are qualified as certified firefighters in the State of Ohio, and

**WHEREAS**, Council has determined that there is good cause to accept the recommendation of the Fire Chief, therefore:

**NOW, BE IT RESOLVED** by the Council of the City of Reminderville, County of Summit, State of Ohio:

**SECTION 1.** That Fire Lieutenant Eric Jones is hereby transitioned to a full-time Lieutenant Firefighter/Paramedic in the Reminderville Fire Department and to be paid an annual salary of \$75,067.28.

**SECTION 2.** That Nicholas Zagorski is hereby transitioned to a full-time Firefighter/EMT in the Reminderville Fire Department and to be paid an annual salary of \$61,420.32.

**SECTION 3.** That Steel Farkas is hereby transitioned to a full-time Firefighter/EMT in the Reminderville Fire Department and to be paid an annual salary of \$61,420.32.

**SECTION 4.** The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

**SECTION 5.** That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the City of Reminderville, to wit: to ensure immediate placement, and if this Resolution receives the necessary number of votes, it shall take effect and be in force from and after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
