A RESOLUTION TO HIRE INDEPENDENT CONTRACTORS AS PERSONAL TRAINERS AND FITNESS INSTRUCTORS FOR THE REMINDERVILLE ATHLETIC CLUB, AND DECLARING AN EMERGENCY.

SECTION 3. That Jeff Janzig is hereby hired as an independent contractor for the Reminderville Athletic Club to be an Instructor for Cycling effective July 1, 2023 through December 31, 2023, and will be paid according to the Agreement, attached hereto and made a part hereof, and

SECTION 4. That John Hornyak is hereby hired as an independent contractor for the Reminderville Athletic Club to be an Instructor for Cycling, effective July 1, 2023 through December 31, 2023, and will be paid according to the Agreement, attached hereto and made a part hereof, and

SECTION 5. That Marina Rotenberg is hereby hired as an independent contractor for the Reminderville Athletic Club to be an Instructor for Zumba effective July 1, 2023 through December 31, 2023 and will be paid according to the Agreement, attached hereto and made a part hereof, and

SECTION 6. That Sarah Krakowski is hereby hired as an independent contractor for the Reminderville Athletic Club to be an instructor for various classes, effective July 1, 2023 through December 31, 2023 and will be paid according to the Agreement, attached hereto and made a part hereof, and

SECTION 7. That Elizabeth Lear is hereby hired as an independent contractor for the Reminderville Athletic Club to be an Instructor for yoga effective July 1, 2023 through

December 31, 2023, and will be paid according to the Agreement, attached hereto and made a part hereof, and

SECTION 8. That Ignite Volleyball is hereby hired as an independent contractor for the Reminderville Athletic Club to be a Personal Trainer, effective July 1, 2023 through December 31, 2023, and will be paid according to the Agreement, attached hereto and made a part hereof, and

SECTION 9. That Stacey O’Keefe is hereby hired as an independent contractor for the Reminderville Athletic Club to be a Personal Trainer, effective July 1, 2023 through December 31, 2023, and will be paid according to the Agreement, attached hereto and made a part of hereof, and

SECTION 10. That Stacey O’Keefe is hereby hired as an independent contractor for the Reminderville Athletic Club to be an Instructor for various classes, effective July 1, 2023 through December 31, 2023, and will be paid according to the Agreement, attached hereto and made a part hereof, and

SECTION 11. That Toni Goldston is hereby hired as an independent contractor for the Reminderville Athletic Club to be an Instructor for various classes, effective July 1, 2023 through December 31, 2023, and will be paid according to the Agreement, attached hereto and made a part hereof, and

SECTION 12. The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 13. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the City of Reminderville, to wit: to ensure immediate placement, and if this Resolution receives the necessary number of votes, it shall take effect and be in force from and after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
