

RESOLUTION NO. 54-2023

A RESOLUTION TO HIRE JORDAN SOPPEL, JORDAN FABRY, RYAN MORYC, AND JANYA FORTE AS CAMP COUNSELORS/FRONT DESK ASSOCIATES FOR THE REMINDERVILLE ATHLETIC CLUB AND TO BE PAID AT THE RATE OF TEN DOLLARS AND 10/100 (\$10.10) PER HOUR, AND DECLARING AN EMERGENCY.

WHEREAS, the Director of the Reminderville Athletic Club has recommended hiring front desk associates for the Reminderville Athletic Club, and

WHEREAS, Council finds good cause to accept the recommendation of the Director of the Reminderville Athletic Club, and therefore

NOW, BE IT RESOLVED by the Council of the City of Reminderville, County of Summit, State of Ohio:

SECTION 1. That Jordan Soppel is hereby hired as a camp counselor/front desk associate for the Reminderville Athletic Club, effective June 8, 2023, to be paid at the rate of \$10.10 per hour.

SECTION 2. That Jordan Fabry is hereby hired as a camp counselor/front desk associate for the Reminderville Athletic Club, effective June 8, 2023, to be paid at the rate of \$10.10 per hour.

SECTION 3. That Ryan Moryc is hereby hired as a camp counselor/front desk associate for the Reminderville Athletic Club, effective June 8, 2023, to be paid at the rate of \$10.10 per hour.

SECTION 4. That Janya Forte is hereby hired as a camp counselor/front desk associate for the Reminderville Athletic Club, effective June 8, 2023, to be paid at the rate of \$10.10 per hour.

SECTION 2. The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 3. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the City of Reminderville, to wit: to ensure immediate placement, and if this Resolution receives the necessary number of votes, it shall take effect and be in force from and after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
