

City of Reminderville Council Meeting June 13, 2023

Call to Order

Approval of Minutes

Mr. Wiggins moved to approve the minutes from May 23, 2023. Mr. DiCarlo seconded. All in favor.

Joe Burian 10557 Florida Street

Mr. Burian thanked Council and Mayor Alonso for helping to make Reminderville one of the nicest cities he has ever visited. He feels the maintenance department do a spectacular job, better than any other city. He feels they are not duly compensated for their skills. They fix machines, do repairs at the RAC and he feels that is more than what other maintenance departments do. The Solon service department went on strike for not being compensated

fairly. Twinsburg pays \$24.75, Aurora pays \$25, Hudson pays \$26 – the average being \$25.50 per hour. Reminderville pays \$20.70 and he feels that is not enough to afford to live in Reminderville. He hopes they don't leave or get poached by another community. He would like the Human Resources Committee to focus on better wages to retain them. He added the service department employees told him they would like to make more money. He feels they deserve another pay raise and it would send a good message to those employees and to the residents.
