

RESOLUTION NO. 74-2023

A RESOLUTION AUTHORIZING MAYOR ALONSO TO ENTER INTO AN AGREEMENT WITH FABRIZI TRUCKING & PAVING CO. FOR THE CLIPPER COVE CULVERT REPLACEMENT PROGRAM IN AN AMOUNT NOT TO EXCEED ONE MILLION ONE HUNDRED TWENTY- THREE THOUSAND THREE HUNDRED NINETY DOLLARS AND 05/100 (\$1,123,390.05), AND DECLARING AN EMERGENCY.

WHEREAS, OHM has recommended to Council for the City of Reminderville that there is a need for replacement of the culvert in Clipper Cove, and

WHEREAS, OHM has received several bids for the project, and

WHEREAS, OHM has determined Fabrizi Trucking & Paving Co. has submitted the lowest and best bid and OHM has recommended to Council that they accept said bid, and

NOW, BE IT RESOLVED by the Council of the City of Reminderville, County of Summit, State of Ohio:

SECTION 1. That the City of Reminderville hereby awards Fabrizi Trucking & Paving Co. the contract for the Clipper Cove Culvert Replacement Project in an amount not to exceed one million ninety-six thousand three hundred ninety-nine and 05/100 dollars (\$1,096,399.05) for the base bid plus alternate #1 in the amount of twenty-six thousand nine hundred ninety-one and 00/100 dollars (\$26,991.00) for a total of one million one hundred twenty- three thousand three hundred ninety and 05/100 dollars (\$1,123,390.05)

SECTION 2. That the recommendation letter from OHM is marked Exhibit "A" and made a part hereof.

SECTION 3. The Council finds and determines that all formal action by this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

SECTION 4. That this Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, comfort, convenience, and general welfare of the inhabitants of the City of Reminderville, to wit: to insure the project begins at the earliest possible time, and if this Resolution receives the necessary number of votes, it shall take effect and be in force after its passage; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
